PLEASE NOTE! Social security and organizational numbers regarding Invoice and installments are only to be used in WebPay's test environment – and not for any other purposes in any other systems.

PLEASE NOTE! As Companies in Sweden may have more than one address, we will return two addresses on our Swedish business test reply.

PLEASE NOTE! When testing installments, the total amount must be at least 500 kr.

6.2 Test card number swedish acquiring agreement

The following information can be used if you want to test card purchases with Payment Method: SVEACARDPAY

Card number for successful authorization

To test denied payments change the payment amount to 1 in the end. (minor currency)	
Example: A payment with amount: 10000 will result in "Success". A payment with amount: 10001 will result in "Denied by bank".	

CVV/Control Numbers: any three-digit number.

Valid for: any date in the future

6.3 Testing Anti-Fraud for Swedish acquirers

If the merchant company is using our anti-fraud services, they must have an agreement for BIN control and / or IP control. When the service is activated in our system – go to "Anti-Fraud" in the store profile and add or remove the countries that you want to accept cards from, and/ or the countries from whom you want to accept the IP number from.

The following short codes can be used when testing BIN control:

US	4001160022223300
NO	4001920022223300
SE	4444333322223300

If you want to test our IP-based country restriction, you can test by only allowing incoming orders from Norway. (If you are located in a country other than Norway).

This feature means that you can configure the shop to only allow orders from certain countries based upon the customers IP-addresses.
